Mr. RASKIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3494) to authorize appropriations for fiscal year 2020 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes; relating to the consideration of House Report 116-125 and an accom-

panying resolution; relating to the consideration of measures disapproving of sales, exports, or approvals pursuant to the Arms Export Control Act; and providing for consideration of the resolution (H. Res. 489) condemning President Trump's racist comments directed at Members of Congress.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3494) to authorize appropriations  
6 for fiscal year 2020 for intelligence and intelligence-re-  
7 lated activities of the United States Government, the Com-  
8 munity Management Account, and the Central Intelligence  
9 Agency Retirement and Disability System, and for other  
10 purposes. The first reading of the bill shall be dispensed  
11 with. All points of order against consideration of the bill  
12 are waived. General debate shall be confined to the bill  
13 and amendments specified in this section and shall not ex-  
14 ceed one hour equally divided and controlled by the chair  
15 and ranking minority member of the Permanent Select  
16 Committee on Intelligence. After general debate the bill  
17 shall be considered for amendment under the five-minute  
18 rule. In lieu of the amendment in the nature of a sub-  
19 stitute recommended by the Permanent Select Committee  
20 on Intelligence now printed in the bill, an amendment in

1 the nature of a substitute consisting of the text of Rules  
2 Committee Print 116-22, modified by the amendment  
3 printed in part A of the report of the Committee on Rules  
4 accompanying this resolution, shall be considered as  
5 adopted in the House and in the Committee of the Whole.  
6 The bill, as amended, shall be considered as the original  
7 bill for the purpose of further amendment under the five-  
8 minute rule and shall be considered as read. All points  
9 of order against provisions in the bill, as amended, are  
10 waived. No further amendment to the bill, as amended,  
11 shall be in order except those printed in part B of the  
12 report of the Committee on Rules. Each such further  
13 amendment may be offered only in the order printed in  
14 the report, may be offered only by a Member designated  
15 in the report, shall be considered as read, shall be debat-  
16 able for the time specified in the report equally divided  
17 and controlled by the proponent and an opponent, shall  
18 not be subject to amendment, and shall not be subject to  
19 a demand for division of the question in the House or in  
20 the Committee of the Whole. All points of order against  
21 such further amendments are waived. At the conclusion  
22 of consideration of the bill for amendment the Committee  
23 shall rise and report the bill, as amended, to the House  
24 with such further amendments as may have been adopted.  
25 The previous question shall be considered as ordered on

1 the bill, as amended, and on any further amendment  
2 thereto to final passage without intervening motion except  
3 one motion to recommit with or without instructions.

4 SEC. 2. If House Report 116-125 is called up by di-  
5 rection of the Committee on Oversight and Reform: (a)  
6 all points of order against the report are waived and the  
7 report shall be considered as read; and (b)(1) an accom-  
8 panying resolution offered by direction of the Committee  
9 on Oversight and Reform shall be considered as read and  
10 shall not be subject to a point of order; and (2) the pre-  
11 vious question shall be considered as ordered on such reso-  
12 lution to adoption without intervening motion or demand  
13 for division of the question except one hour of debate  
14 equally divided and controlled by the chair and ranking  
15 minority member of the Committee on Oversight and Re-  
16 form.

17 SEC. 3. (a) A joint resolution described in section 4  
18 shall be privileged if called up by the chair of the Com-  
19 mittee on Foreign Affairs or a designee on the day after  
20 the calendar day on which the Majority Leader or a des-  
21 ignee announces an intention that the House consider the  
22 joint resolution. The joint resolution shall be considered  
23 as read. All points of order against the joint resolution  
24 and against its consideration are waived. The previous  
25 question shall be considered as ordered on the joint resolu-

1 tion to its passage without intervening motion except: (1)  
2 20 minutes of debate equally divided and controlled by the  
3 chair and ranking minority member of the Committee on  
4 Foreign Affairs or their respective designees; and (2) one  
5 motion to recommit (or commit, as the case may be). A  
6 motion to reconsider the vote on passage of the joint reso-  
7 lution shall not be in order.

8 (b) On demand of the chair of the Committee on For-  
9 eign Affairs or a designee, debate pursuant to subsection  
10 (a)(1) shall be one hour equally divided and controlled by  
11 the chair and ranking minority member of the Committee  
12 on Foreign Affairs or their respective designees.

13 SEC. 4. A joint resolution referred to in section 3 is  
14 a Senate joint resolution, or a House joint resolution re-  
15 ported by the Committee on Foreign Affairs, prohibiting  
16 any of the following under section 36 of the Arms Export  
17 Control Act (22 U.S.C. 2776):

18 (1) a proposed sale pursuant to subsection (b);  
19 (2) a proposed export pursuant to subsection  
20 (c); or  
21 (3) an approval pursuant to subsection (d).

22 SEC. 5. Sections 36(b)(3), 36(c)(3)(B), and  
23 36(d)(5)(B) of the Arms Export Control Act shall not  
24 apply in the House during the remainder of the One Hun-  
25 dred Sixteenth Congress.

1        SEC. 6. Upon adoption of this resolution it shall be  
2 in order without intervention of any point of order to con-  
3 sider in the House the resolution (H. Res. 489) con-  
4 demning President Trump's racist comments directed at  
5 Members of Congress. The resolution shall be considered  
6 as read. The previous question shall be considered as or-  
7 dered on the resolution and preamble to adoption without  
8 intervening motion or demand for division of the question  
9 except one hour of debate equally divided and controlled  
10 by the chair and ranking minority member of the Com-  
11 mittee on the Judiciary.
